The **Portos e Caminhos de Ferro de Moçambique, E.P. (Mozambique Ports and Railways)** has received financing from the New Partnership for Africa's Development - Infrastructure Project Preparation Facility (NEPAD IPPF), hosted by the African Development Bank, toward the cost of the **Environmental and Social Impact Studies for the Proposed Machipanda Railway Rehabilitation Project**, and intends to apply part of the agreed amount for this grant to payments under the contract for the **Consultancy Services for Operationalisation, and Implementation of the Environmental and Social Management System (ESMS) and Integrated Environmental and Social Management Plan (ESMP) for Caminhos de Ferro de Moçambique (CFM)**, along with the development of **Climate Risk Management Tools, and Green House Gases (GHG) Accounting Methodologies**.

The main objective of this consultancy is to support CFM in the roll out and operationalisation of its Environmental and Social Management System (ESMS) and the implementation of its integrated Environmental and Social Management Plan (ESMP). The assignment will strengthen institutional processes and procedures, ensure effective application across CFM's operations, and build staff capacity for long-term ownership. It also encompasses the development of new workstreams, climate-risk management tools, and greenhouse gas (GHG) accounting methodologies, ensuring compliance with regulatory and financing institution standards while fostering accountability, inclusiveness, resilience, and sustainability in CFM's railway and port operations.

The estimated duration of the assignment is 12 (twelve) months.

The **Mozambique Ports and Railways (Portos e Caminhos de Ferro de Moçambique, E.P.)** now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's ***"Procurement Policy for Bank group funded operations"*** which entered into force on October 2015 and is available on the Bank's website at <https://www.afdb.org/en/projects-and-operations/procurement/new-procurement-policy>.
